

## School fees and other charges 2011/12

### Fees for photocopies and insurance

For regular school lessons during a school year, additional material is necessary (photocopies, etc.) that cannot entirely be covered by the school's budget. A specific amount is payable for each pupil; 11 EURO per child in Kindergarten, 21.50 EURO (+ 20 EURO Intermath) per child in the Primary School and 28.00 EURO per child in the Secondary School.

Towards the ordering of books that are to be lent by the school, each Primary School pupil is charged a fee of 2.50 EURO. In accordance with the provisions of article 34 of the "General Rules of the European Schools" all children are covered by the school's insurance. Parents must contribute 2.40 EURO per pupil towards this insurance, in the kindergarten it is 1.00 EURO per child. The fee for the Secondary School graduation exam is 80.32 EURO. Additional fees for swimming and art lessons may apply depending on the year level.

You will receive an invoice of the total amount in the autumn of each school year, which must be paid in the current school year no later than 31<sup>st</sup> October 2011.

### Lockers (Secondary School)

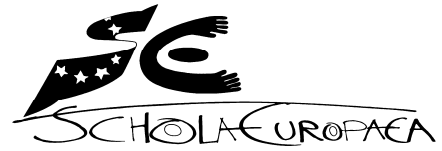
The Secondary School pupil can rent a locker for 20.00 EURO per school year. The allocation of lockers takes place at the beginning of each school year. All pupils have to purchase their own padlocks. The charge of 20.00 EURO per locker was determined by the Financial Committee in Brussels in April 1997.

### Tuition fee for category III – pupils ("private pupils")\*

The tuition fee for category III pupils is annually adjusted and determined by the Board of Governors of the European Schools (BOG). It can vary from year to year.

For school year 2011/2012 the tuition fee is:

**Primary School:** 3,716.34 €  
**Secondary School:** 5,067.74 €



**Procedure for families with several children:**

First child:

The full tuition fee must be paid for the child who is currently in the highest school level.

Second child:

50 % of the normal tuition fee that applies to the child's current school level.

Three children or more:

25 % of the normal tuition fee according to the child's current school level. However, the amount must be at least € 1.351,38 (50 % of the Kindergarten fee).

**The payment of school tuition fees for 2011/12 are as follows:**

Before 30/06/2011: payment in full or at least 25 % (if instalments are arranged)  
Admission for school year 2011/12 is only possible if there is no delay in the payment of at least 25 %

Before 31/10/2011: payment of the remaining 75 % and of the other fees (photo copies, insurance, school leaving examination fee)  
or  
when payment in instalments has been arranged (debit order must be presented)

31/10/2011: 25 % plus other fees

31/01/2012: 25 %

31/03/2012: 25 %

**School tuition fees:**

A tuition fee reduction can be requested from the Director. The processing of this request requires an close examination of the current income situation. Please take note that the income limits are set very low. Regardless of the income levels, the minimum tuition fee is 25 % of the regular tuition fee.

\* Private pupils (category III pupils) are pupils who are neither belong to category I nor category II.

**Category I:** children whose parents are employed by: European Patent Office, European Commission, European Parliament, European Court, EFDA / ITER EDA, European School

**Category II:** Children whose parents who work for companies that have signed a contract with the ESM
